

PARTICIPANT LIABILITY RELEASE, HOLD HARMLESS AND INDEMNIFICATION FORM

I, the undersigned participant/parent/guardian, request voluntary participation for myself/minor to participate in events, including aquatic and dryland activities, which are hereinafter referred to as the "activities" taking place at the Coronado Unified School District (CUSD).

I consent to my/minor's participation in the activities and acknowledge that I/minor fully understand my/minor's participation may involve risk of serious injury or death, including losses which may result not only from my/minor's own actions, inactions or negligence, but also from the actions, inactions, or negligence of others, the condition of the facilities, equipment, or areas where the event or activity is being conducted, and/or the rules of play of this type of event or activity. I understand that if I/minor have any risk concerns, I should discuss the risks associated with my participation with the activity coordinators and event staff, before I sign this document and before any activities begins.

I acknowledge that I am aware that there are risks to me/minor of exposure to directly or indirectly arising out of, contributed to, by, or resulting from an outbreak of any and all communicable disease, including but not limited to, the virus "severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2)", which is responsible for Coronavirus Disease (COVID-19) and/or any mutation or variation thereof.

I certify that I/minor is in good health and have no physical condition that would prevent participation in this activity. Furthermore, I agree to use my/minor's personal medical insurance as a primary medical coverage payment if accident or injury occurs. I consent to emergency medical treatment in the event such care is required.

In consideration of having the opportunity to participate as either an individual, team member, lesson participant, or competitor at the CUSD facility, I acknowledge that I am aware of and willing to assume the risks associated with these activities at the CUSD facility. I hereby voluntarily agree to waive, hold harmless and indemnify the Coronado Unified School District its trustees, agents, volunteers and employees from any and all claims, demands, damages and causes of action of any nature whatsoever arising out of ordinary negligence which I/minor, my heirs, my assigns or successors may have against them for, on account of, or by reason of my/minor's participation in the above activities. I indicate my agreement to this hold harmless elective noted below.

Release & Indemnification – Participant's & Parent's Rights: In consideration of allowing myself/minor to participate in the activities, agree to indemnify, save and hold harmless **Coronado Unified School District its Board of Trustees, Officers, employees, and agents** from any and all claims, demands, losses, damages and liabilities for indemnities, contribution or otherwise with respect to any damage and/or injury, of any type, arising from participation in the activities. The undersigned also agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasee and is intended to be as broad and inclusive as is permitted by the laws of the State in which the Event(s) is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

By completing this form and participating in the this program, you must confirm that you will abide by the most current guidelines of the County of San Diego Public Health Order. You attest that you have reviewed the current County guidelines document that identifies ways to prevent the spread of COVID-19.

You understand that your use of the fields is limited to practice and drills.

You understand that group activities will be organized in stable groups of 12 participants. There will be no interaction (i.e. scrimmaging) between different stable groups. Per the County protocols you must remain in your assigned stable group throughout the program.

You attest that you will not enter a Coronado Unified School District Facility if your temperature is above 100° F or if you have COVID-19 symptoms based on CDC guidelines.

You attest that if you have displayed COVID-19 symptoms, you will not return to any Coronado Unified School District facility until you have tested negative for COVID-19 and provide a medical professional's clearance; or at least 10 days have passed since the onset of symptoms, and at least 3 days (72 hours) have passed since recovery (no fever without the use of fever reducing medication).

You will not bring anyone not participating in the activity on to the Coronado Unified School District Facility.

Participants that are not from the same household may not carpool to and from the facility.

You attest that you will refrain from unnecessary physical contact with others, including hugs, high fives, and fist pumps which are not permitted per the County protocols.

You will sanitize your hands at the beginning, middle and end of the activity.

Equipment bags must be kept within the area for each stable group, and each bag must be 6 feet from each other.

Participants must bring enough water as drinking fountains will not be available.

You acknowledge that restrooms may not be available and will plan accordingly.

Due to the nature of the activity, it is possible that equipment such as but limited to balls may be shared. Participant will sanitize their hands before and after use of shared equipment.
